**Hello Parents/Guardians of Youth Volunteers!**

We recognize there are times when it is appropriate for youth volunteers - who are themselves under age 18 - to assist in caring for children during church activities and events. Youth volunteers who serve as helpers fill an important role in Timonium Presbyterian Church's ("TPC") ministries (1 Corinthians 12:4-6). They can be great role models for the children, and can aid the adult volunteers. They can also add energy and excitement to each event...and we are thankful to have them help if they are eligible to do so. Eligibility is defined by, but not limited to, the following guidelines: 1) Unless an exception is made by the Session, **all minor applicants must be 14-years old to be considered for volunteering at TPC's youth events and ministries;** and 2) all minor applicants will be screened, and Sessionally approved, as specified below.

**Hello Potential Youth Volunteers!** *(Parents, please have your child read this section.)*

**To our youth volunteers**, there are several things we would like you to reflect on before signing up as a volunteer. As a youth volunteer, you become a role model to the younger children. *You are to be a great example to the children attending.* Your enthusiastic participation and responsible attitude will help set the tone for events and ministries. It is important to realize while you may not be an adult, we expect you to act in a mature manner with courtesy, kindness, integrity, and care. You are to have a willing spirit that seeks to help the adults you are assisting. You are to show the children attending TPC's ministry event God's truth and love through your words and actions.

**Parents**, if this is a right fit for your child's personality, gifts, and readiness to take on responsibility, then please encourage them to apply to help! We hope they will have a lot of fun while serving, and join in all the games, recreation, music, and instruction.

In addition to this **2016-2017 Annual Form**, and attending the required Church Safety Seminar, your child will also need **two Reference Forms** sent to TPC from adults (e.g., church workers (not including the pastoral staff or relatives), coaches, school teachers, scout leaders, etc.) who have observed your child interact with other minors and can comment on their suitability for working with them.<sup>2</sup> **These documents must be on file BEFORE your child will be approved to serve in a volunteer capacity.**
